The primary responsibility of the Mental Health Therapist position is providing individual, group, and family therapy to children and teens, ages 6-17 in foster care and homeless teens, ages 16-20. - Demonstrates respect for the inherent dignity and worth of the clients.
- Actively monitors client progress towards goals and addresses termination/discharge related issues, providing outside referrals at discharge/termination, as appropriate.
